Mr. Cook told of the changing shopping patterns with Amazon outpacing "brick and mortar" stores. Who ever thought Santa Anita Mall would have major restaurant tenants and Gold's Gym. Restaurant are the new anchor tenants, just look at our new Camellia Square.

Mr. Cook left us with his 15 second elevator speech, "If you are looking for one of the Safest Cities in California, If you are looking for a City will a top rated school district, If you are looking for a City which has seen a strong and steady rise in property values, If you are looking for a City with a solutions-based approach to economic development, Then you are looking at investing in Temple City today".

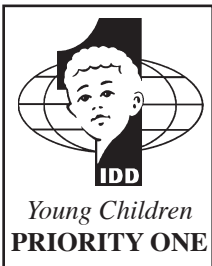
